This is Special Agent Ben Ziesemer with the, the date is June 23, 2005 it's approximately 10:02 a.m. Unintelligible...will be a recorded phone call to phone number (5-0-3) 9-5-7-0-1-9-0.

Ringling:

Bacon: Hello

S/A Ziesemer: Hey, is this David?

Bacon: Hello

S/A Ziesemer: Hello is this David?

Bacon: Yes it's David

S/A Ziesemer: Hey David my names Ben, I got a uh, I bought a Ruger 9mm from ya in Vancouver at the gun show, few months ago and you....

Bacon: Uhhhh...

S/A Ziesemer: ...you guys had a uh, Para Ordnance, uh forty that I was lookin' at too. I just.....

Bacon: Um, yeah, yeah that was uh my friend, Alex.

S/A Ziesemer: Oh, okay, um well you wrote your, you wrote your number on uh, on uh card with him

Bacon: Yeah....

S/A Ziesemer: Do you guys still.....

Bacon: Unintelligible.....some of the stuff is mine, some of the stuff is his.

S/A Ziesemer: Oh, okay. Well

Bacon: If your, if your asking about the Para Ordnance though, he sold that about a month ago

S/A Zieseemer: Oh, okay. Well I'm lookin' like uh, I got some money finally, I'm lookin' for like uh, maybe like a forty or a forty-five, you, you guys have anything like that?

Bacon: Uh we, the only thing we have right now is a Smith & Wesson uh, P99, like the Walther.

S/A Zieseemer: Oh really is it, that's uh, what's that uh, a 9mm.

Bacon: Um, no it's actually in a forty

S/A Zieseemer: Oh it's a forty

Bacon: Yeah

S/A Zieseemer: Oh yeah that's sweet, those are like the uh, they have like the cool new lookin' ones that look like kind of uh, uh, well I mean there like the Walther pistol, but there made by Smith & Wesson or somethin'

Bacon: Yeah exactly, and the advantage to that is that the Walther pistol use uh, there own uh rail system and the Smith & Wesson are universal rails so you can put a regular flashlight or whatever on it

S/A Zieseemer: Oh cool, how much uh, how much you guys willin' to sell that one for?

Bacon: Oh, I'm lookin' to get four and a quarter out of it

S/A Zieseemer: Oh, that's not bad

Bacon: Yeah and it's uh, unintelligible... sells new for uh, for, four ninety-nine or more, the cheapest gun store around has it for four ninety nine. It was just a uh recent uh trade in item unintelligible:....the, the uh, the only reason I decided sellin' it because I don't know if your familiar with it, it has this de-cocker built into the slide so there's no lever

S/A Zieseemer: Uh, huh

Bacon: It's just built in and I'm left handed and I have ta, shift my whole grip position to uh use my finger to actuate the de-cocker.

S/A Zieseemer: Okay, well I'm right handed so that shouldn't be a problem, yeah that....

Bacon: Yeah

S/A Zieseemer: ...pretty sweet though uh, I'm uh, I kinda drive around a lot work, but uh are you, where you at?

Bacon: Um, I'm, I'm right now uh, meeting some people out in the uh Clackamas area....Gresham, Clackamas area

S/A Zieseemer: Okay, well uh...

Bacon: So if ya want to uh, if you wanna' work somethin' out maybe this evening uh if you want to uh take a look at it or somethin' that'd be great

S/A Zieseemer: Okay that'd be good, what time be good for you, like uh, I don't know, like four.....

Bacon: Um

S/A Zieseemer:or five

Bacon: Um yeah pretty much anytime after five or six would be great

S/A Zieseemer: Okay, I'll give ya a call uh, later maybe we could meet like uh, I don't know, somewhere like on the border or ____ somewhere close in between for both of us

Bacon: Yeah, are are you uh, are you getting closer to I-5 or 2-0-5

S/A Zieseemer: Um, well right, I can do either, I'm probably closer to 2-0-5

Bacon: Okay, that would work well for me too.

S/A Zieseemer: Oh, okay

Bacon: Cause I'll be near 2-0-5 today, so..... unintelligible

S/A Zieseemer: Uh, I'll give ya a call, maybe around like uh two or three somethin'

Bacon: Okay, I'll talk to ya unintelligible....

S/A Zieseemer: Alright thanks

Bacon: Bye
